Note :-

- (1) As per the direction of the Hon'ble High Court in M.C.A. No. 01/2018 in S.C.A. No. 18303 to S.C.A. No.18306 with S.C.A. No. 21549 to S.C.A. No. 21555 of 2017, the Commission had conducted Preliminary Test after the completion of interviews in October, 2017.
- (2) 01 post of SEBC category remained vacant, as no candidate was available for the interview.
- (3) **The Weighted Marks of Preliminary Test & Interview are calculated as follows :-**
[Marks obtained in P.T. X 50/300 = Weighted Marks of Preliminary Test] + [Marks obtained in Interview X 50/100 = Weighted Marks of Interview] = Total Weighted Marks

- (4) As per O.O. No. ૨ મગ-૭૫૧૪-૨૦૧૪-અરએનસી dated 20-04-2018, if any candidate remains absent at any stage of the recruitment process, then his/her candidature shall be cancelled. As Dr. Subhash Dnyaneshwar Waghe, bearing E.No. 07, remained absent in preliminary Test, he had not been considered eligible for selection.
- (5) As per Office Order No. PTG-APF-888-Part-2-R&D, dated 26th November,2014 10% marks of the total marks of the preliminary test (i.e. minimum qualifying standard) has been fixed as eligibility criteria to qualify for interviews. As Dr. Shashikant Tejprakash Chaturvedi, bearing E.No. 05 has not been considered eligible for selection as he has obtained less marks than the minimum qualifying standard in the preliminary Test though he was called for interview held before the preliminary Test.
- (6) As per the oral order of the Hon'ble High Court in S.C.A. No. 8690 of 2017, 01 post of General category is kept vacant.
- (7) The above result shall be subject to the final decision of the Hon'ble High Court in S.C.A. Nos. 8690, 13617, 13618, 13619, 13620, 13621, 13622, 13623 and 13624 of 2017.
